

Frequently Asked Questions for Fall 2017 Semester

- 1. Who are eligible to take courses listed under Study Abroad Course? The undergraduate and Korean language courses listed under "Undergraduate Programs > Study Abroad Course > Undergraduate OR Korean Language" are available to all incoming exchange and visiting students of any majors.
- 2. How do I know if the course is taught in English? And how do find if the course is offered at Sinchon Campus (Seoul) or International Campus (Songdo, Incheon)?

The courses taught in English are marked with a reference code ② in the course catalogue. If the course is without a reference code ②, the course is conducted in Korean.

Courses offered at International Campus (Songdo, Incheon) has a reference code © in the course catalogue. If the course is without a reference code ©, it means the course is offered at Sinchon Campus (Seoul).

3. Some courses list prerequisites in their syllabus. How do I know if I am eligible for course registration?

Students are required to check if they are eligible for the class or not by assessing their background of the listed prerequisites. If you are not sure, contact the faculty for advice.

- **4. What if there is no course syllabus for the offered courses yet?**Check the previous semester's course information through online course catalogue, or email your professor to get the syllabus.
- 5. The course I am interested is marked X in the Exchange column of the course catalogue. What does it mean?

It means the course is blocked from exchange/visiting students regardless of their major of study. Even if the course is offered from your major, the course with X in the Exchange column is blocked from all exchange/visiting students because of the department's academic policy and/or instructor's own discretionary.

6. The course I am interested is marked X in the Exchange column of the course catalogue, but the target students written in the syllabus says the course is open to anyone. What should I do?

Please ask the faculty for advice. In some cases, however, even if students have the professor's approval, the department that offers the course does not allow students to register for the course due to the department's academic policies. Thus, please check with the faculty if the department also agrees to enroll you in the course.

7. How many credits do we have to take?

- ➤ Registering below the minimum credit requirement may cause withdrawal from the program and D-2 visa cancellation.
- Some students may have to register for more than 9 credits to maintain their visa status or scholarship or to fulfill their study abroad requirement.

9. When will I be informed of my login credential to access Yonsei Portal Service for course registration?

Your login credential for Yonsei Portal Service will be notified in the first week of August by email. The login credential includes your ID (Yonsei student ID number) and password.

10. I am interested in taking an Intensive Korean Language (KLI) course. How can I enroll in the KLI course?

You must complete registering for a KLI course during Round 1 and 2 of the course registration period (August 7 ~ 11). The number of seats is unlimited, but a KLI course registration must be completed by 17:00, August 11 via Yonsei Portal Service.

11. Can I audit any course?

No, there is no 'audit' option available. Even if your course instructor allows you to audit the course, there will be no benefit of a grade or credit for the course.

12. Is there an 'Incomplete' or 'Pass/Fail' option?

There is no 'Incomplete' grading option at Yonsei University; thus, students must finish their courses during the semester.

Most courses at Yonsei University are letter-graded. There are limited numbers of predesignated Pass/Non-Pass graded courses, which are marked with (a) in the Ref. column of the course catalogue.

13. Do you have more information about the orientation?

Please note that the mandatory orientation is scheduled at 14:00 PM, Tuesday, August 29 at the Main Auditorium of Yonsei University. We will be distributing detailed information on the orientation including schedule, venue, and program by mid-August.

14. When does the Fall 2017 semester start and end?
